In York County, nearly 1 in 3 households is working but still struggling to cover basic living expenses. They make too much to qualify for government assistance, but not enough to keep up with the rising cost of living. They are just one financial emergency away from slipping into poverty. We drop our children off to them in the morning. They take care of our elderly. They check us out in the grocery store. They make our community work; let's make our community work better for them.

The needs of our community are changing. So are we. For 100 years, our United Way has tackled the toughest issues facing our community. We continue this legacy by equitably and collaboratively removing barriers to prosperity. **Our decision to focus on one issue—uplifting our ALICE households—**signals the evolution of our service model, reflecting the changing needs of those we serve, the agencies that deliver essential programs, and the donors that help us make it happen. **We envision an equitably thriving York County where everyone has easy access to comprehensive support on their path to financial stability.**



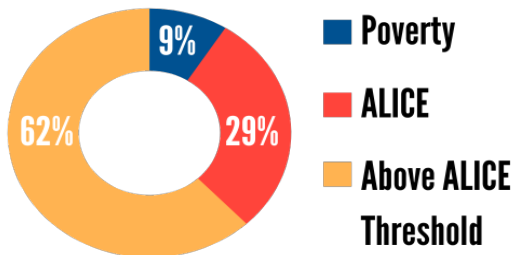

# You Helped Noah Grow

**\$1,354** is the monthly cost of in home childcare center for two children in York County

Because you give, you are changing the lives of children in our community.

Lives like **Noah's, a young, creative two-year-old**. Noah's recently started living with his grandmother, Susan. **Susan is ALICE**. Even though she has a full-time job, she could not afford childcare for Noah. Susan made too much to receive assistance, but not enough to cover the added expenses.

Thanks to your gift to the United Way of York Impact Fund, Susan was able to enroll Noah in a high quality Early Learning Center program with a scholarship. **Noah now comes home every day saying new words and displaying creative activities.**

Because you give, Noah has the opportunity to learn and grow at a wonderful learning center and his grandmother can still work to keep them financially stable.

# Your Support Allowed Sarah to Rebuild

**81%** of single female households in York County are below the ALICE threshold

Because you give, neighbors across our Community were able to rebuild their lives.

Neighbors like Sarah, a survivor of domestic violence and abuse, who is a single mother to a three-year-old little girl. Sarah knew she needed to leave her abusive partner, but didn't earn enough on her own to be financially stable. **Sarah is ALICE.**

Your gift to the United Way of York County Impact Fund gave her the resources to get herself and her daughter to a shelter. During her month at the shelter, she was given the support she needed to remove the barriers keeping her from being financially stable.

Sarah now is working towards her goals and is able to support herself and her daughter independently. She has childcare that lets her work fulltime and have a safe place to live.

# You Helped Jill Keep Her Home

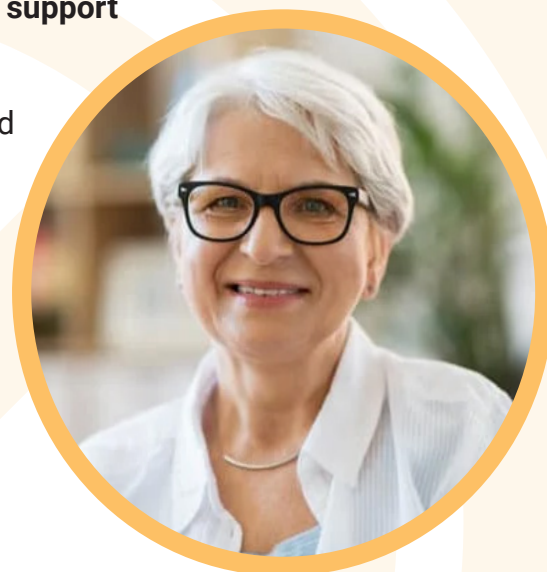
**29%** of York County households live below the ALICE threshold: Working hard, but struggling to afford the basics and make ends meet

**The Volunteer Income Tax Assistance (VITA) program offers free tax preparation and filing** to low--and moderate--income individuals, families, persons with disabilities, older adults, and limited English-speaking taxpayers who need assistance in preparing their own **tax returns in York County**.

**Because you give, people across our community are receiving the supports they need to make ends meet.**

**People like Chris, a veteran, husband, and father.** Chris needed help filing his taxes but unfortunately he could not afford the application fee.

Through the Volunteer Income Tax Assistance (VITA), Chris was able to complete his taxes for free. Getting the full refund he earned was so important because it helped him catch up on some major expenses he'd been putting off during the year.
