A Message from the Board Chair & President

In the first year of our United Way of York County’s issue-focused transition, we directed our attention to **ALICE**, or Asset Limited, Income Constrained, Employed. These are hardworking individuals who make more than the Federal Poverty Line, but less than what it takes to be financially stable. ALICE are our friends and neighbors, and we cannot stand idly by and allow these households to fall into financial disarray.

We’ve set a goal to assist 8,000 hardworking households on their journey toward financial stability by 2033. In order to understand the barriers that are holding ALICE back, we conducted comprehensive summits where ALICE had the chance to share their struggles directly. Two significant barriers became clear: **childcare and transportation**. Without affordable and accessible childcare, ALICE can’t be a dependable employee, and they are denying their children the best start in life. And without reliable transportation, ALICE faces challenges in arriving to and from work in the manner which they so desire.

The United Way of York County is uniquely positioned to lead our community toward change in these spaces. By starting conversations, convening influential partnerships, and measuring collective impact, we are certain that together we can make a positive change for ALICE.

ALICE Needs Our Help

In York County, **1 in 4** households, or 25%, are defined as ALICE. United for ALICE released data from 2022 that shows up to **46,000 households** are living paycheck to paycheck across our community. They are one flat tire or broken washing machine away from falling into poverty, and struggle to keep up with rising costs. This leads to a lack of savings and little to no financial plan on the horizon.

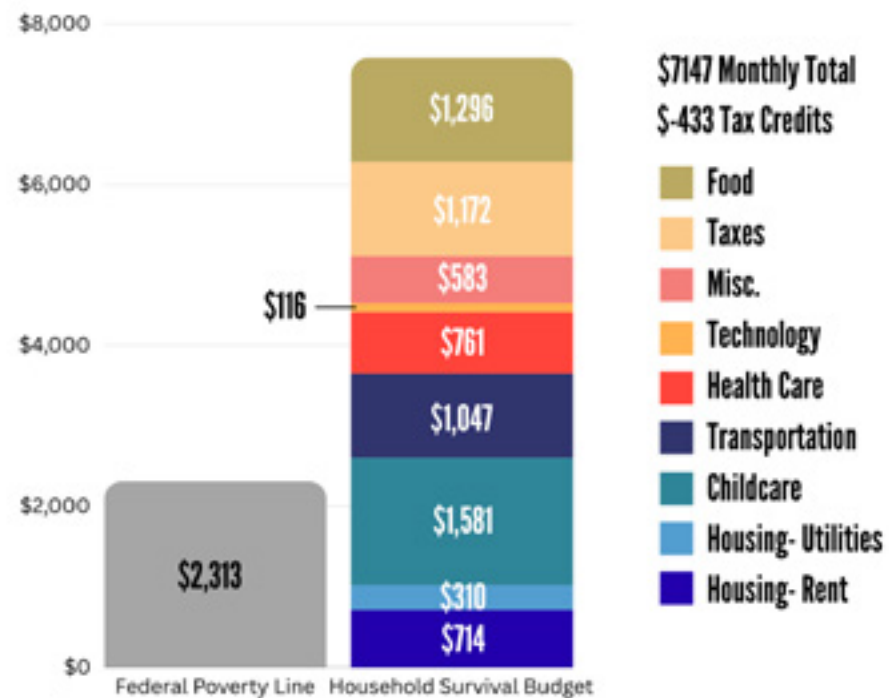
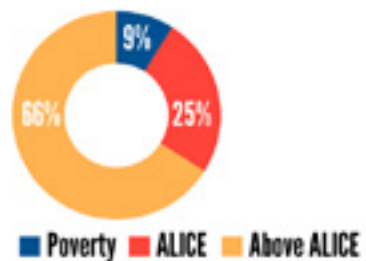

Dollars went directly back into the pockets of hardworking ALICE families.

The Volunteer Income Tax Assistance Program (VITA) offers free tax preparation and filing to low- and moderate-income individuals, families, persons with disabilities, the elderly, and limited English-speaking taxpayers who need assistance in preparing their own tax returns in York County.

During the 2023 tax season, **seven** sites were established to meet ALICE where they are and provide an in-person opportunity for these individuals to file their taxes.

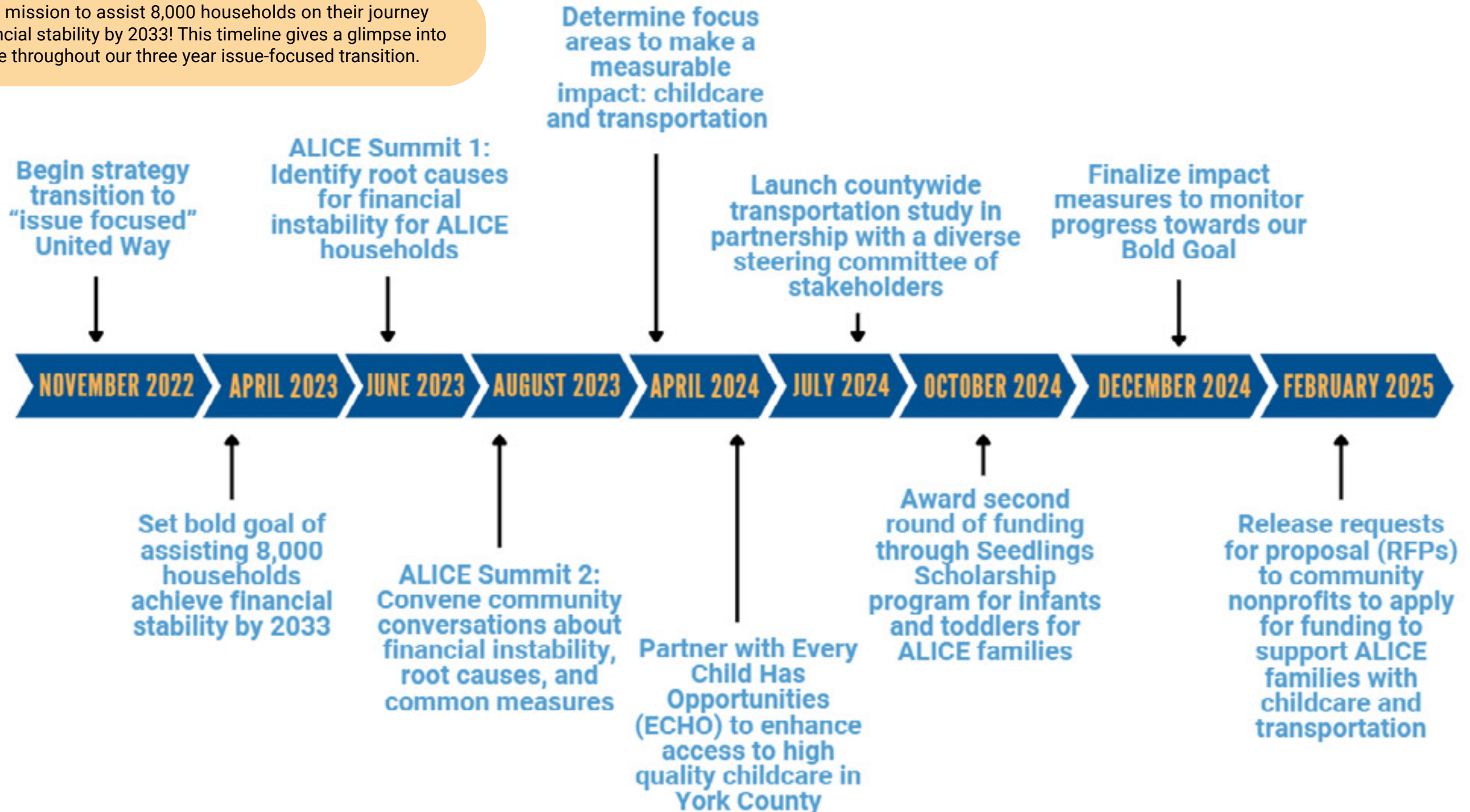
